**I. CALL TO ORDER :**

The BAC Chairperson called the pre-bid conference to order at 10:14am. She informed that the pre-bid conference was meant for the Project: Procurement of Equipment Cases. After acknowledging the presence of the BAC Members and TWG, and noting that no bidder came to attend the pre-bid conference, she called on the BAC Secretariat to discuss the succeeding schedule of the bidding.


**II. BUSINESS MATTERS DISCUSSED:**

The BAC Secretariat informed the Committees that the Project was advertised at the PhilGEPS website, RTVM Facebook in the absence of RTVM website which currently faces downtime period from Dept. of Information and Communication Technology, and at conspicuous places. Invitation letters were also sent to three (3) observers last Sept. 17, 2019 and which were duly received. She reported that the document request list from the PhilGEPS showed at least four (4) prospective suppliers who have viewed the advertisement but as of date none of them purchased bid documents. According to the BAC Secretariat, the prospective bidders for this project still have time until the bid opening date which is Oct. 7, 2019 to purchase bid documents and submit bid/s, and only by that time could the BAC determine the status of the public bidding.



**III. ADJOURNMENT**


Having no other matter to discuss regarding the project, the Presiding Officer thanked all the attendees and adjourned the Pre-Bid Conference at 10:30am.


