**BAC RESOLUTION RECOMMENDING APPROVAL FOR DECLARATION OF FAILURE OF BIDDING**

WHEREAS, the Presidential Broadcast Staff-RTVM (PBS-RTVM) has an Approved Budget for the Contract in the amount of One Million Three Hundred Eighty Six Thousand (Php1,386,000.00) for the procurement of Project: Procurement of DSLR Cameras with Purchase Request #2020-08-173 dated August 20, 2020;

WHEREAS, in compliance with Sec. 10 of Rule IV of the 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act 9184 which requires all procurement shall be done through competitive public bidding except as provided in Rule XVI of the IRR, the Bids and Awards Committee, on its Pre-Procurement Conference held on August 25, 2020 approved the Bidding Documents for a national competitive bidding of the aforesated project;

WHEREAS, the Invitation to Bid for the Project was continuously published at the websites of PhilGEPS, @rtvm.gov.ph and at RTVM conspicuous place effective August 27 to Sept 24, 2020;

WHEREAS, a Pre-Bid Conference was conducted on Sept. 10, 2020 and was attended by three (3) prospective bidders;

WHEREAS, on Sept 24, 2020, bid opening day for the Project's public bidding, three bids were received but only two were opened due to the failure of one bidder to submit complete bid requirements on the technical component of its bid;

WHEREAS, the bidder who surfaced and was declared as the lowest calculated bid during the bid opening underwent post-qualification and was post-disqualified due to non-responsive technical specifications of its bid;

WHEREAS, in compliance with Sec. 34.6, Rule X of the Revised Implementing Rules and Regulations of RA 9184, the post-qualification process on the second lowest calculated bid was initiated and as a result thereof, the same was post-disqualified due to non-responsiveness of the eligibility document submitted after having been found to have interlocking board of directors and shareholders with the other participating bidder which in effect defeats the objective of a competitive public bidding;

WHEREAS, pursuant to Sec. 35.1( c ), Rule X of the Revised Implementing Rules and Regulations of RA 9184, one of the instances when the BAC shall declare a failure of bidding is when *"All bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiations;*


WHEREAS, in view of the failure of all bids for the Project: Procurement of DSLR Cameras to pass the post-qualification process, the Bids and Awards Committee unanimously agreed to recommend to the Head of the Procuring Entity (HOPE) a failure of the public bidding conducted last Sept. 24, 2020 in compliance with Sec. 35.1( c ) of the Revised Implementing Rules and Regulations of RA 9184;


NOW THEREFORE, WE, the Officers and Members of PBS-RTVM Bids and Awards Committee, in consideration of the foregoing, RESOLVED as it is hereby RESOLVED:

- 1) To recommend approval by the Executive Director of the Presidential Broadcast Staff (Head of the Procuring Entity) the Declaration of Failure of Bidding for the Project: Procurement of DSLR Cameras due to the failure of all bids thereon to comply with all the bid requirements and failed post-qualification.




