

INVITATION TO BID FOR THE PROCUREMENT OF TELEPROMPTING SYSTEM

- 1. The *Presidential Broadcast Staff RTVM*, through the *CY 2022 (NEP)* intends to apply the sum of *Six Hundred Thirteen Thousand Pesos* being the ABC to payments under the contract for the *Procurement of Teleprompting System with identification number, PBS-RTVM2022-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Presidential Broadcast Staff RTVM* now invites bids for the above Procurement Project. Delivery of the Goods is required ninety days upon receipt of Notice to Proceed. Bidders should have completed, within *five (5) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from *Presidential Broadcast Staff* -*RTVM* and inspect the Bidding Documents at the address given below during *Monday* to Friday, 8:00 am to 5:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on November 25 to December 14, 2021 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Two Thousand Pesos (Php 2,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person, by facsimile, or through electronic means.

- 6. The *Presidential Broadcast Staff RTVM* will hold a Pre-Bid Conference¹ on *Dec. 2,* 2021, 10:00 am at RTVM Conference Room, RTVM Building, Malacanang, Manila and/or through video conferencing or webcasting via google or zoom meet which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual *submission and receipt* at the office address indicated below, Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
- 9. Bid opening shall be on *Dec. 14, 2021, 10:00 am* at the given address below *and* via *google or zoom meet.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. The *Presidential Broadcast Staff RTVM* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
