BAC RESOLUTION RECOMMENDING APPROVAL FOR DECLARATION OF FAILURE OF BIDDING

WHEREAS, the Presidential Broadcast Staff-RTVM (PBS-RTVM) has an Approved Budget for the Contract in the amount of Four Million One Hundred Forty Two Thousand Three Hundred Pesos (Php 4,142,300.00 for the Project: Procurement of Broadcast Equipment with Purchase Request #2023-07-215 dated July 11, 2023.

WHEREAS, in compliance with Sec. 10 of Rule IV of the 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act 9184 which requires all procurement shall be done through competitive public bidding except as provided in Rule XVI of the IRR, the Bids and Awards Committee, on its Pre-Procurement Conference held on August 11, 2023 approved the Bidding Documents for a national competitive bidding of the aforesated project;

WHEREAS, the Invitation to Bid for the Project was continuously published at the websites of PhilGEPS, @rtvm.gov.ph and at RTVM conspicuous place effective August 18, 2023 to September 13, 2023

WHEREAS, during the Pre-Bid Conference conducted on August 30, 2023, only one(1) prospective bidder attended the conference.

WHEREAS, on September 13, 2023, bid opening day for the Project's public bidding, still only one(1) bid proposal was received until the set time of 10:00am.

WHEREAS, the lone bidder submitted one(1) original copy of Legal and Technical and one(1) original copy of its Financial Documents. As requested during the Pre-bid conference, the bidder also submitted photocopies of its submitted documents.

WHEREAS, in the presence of the BAC, TWG and the project's end-user representative, the BAC Vice Chairperson opened the properly sealed and signed envelopes. Upon initial examination of the submitted Technical Specifications specifically Item # 5, it was stated that "NOT COMPLY" – TOR specs is for discontinued model. Offered the latest successor model. Given the evident declaration of non-compliance on Item # 5, the BAC resolved to disqualify Solid Video Corporation due to non-responsive technical specifications of its bid;

WHEREAS, pursuant to Sec. 35.1(c), Rule X of the Revised Implementing Rules and Regulations of RA 9184, one of the instances when the BAC shall declare a failure of bidding is when "All bids fail to comply with all the bid requirements or fail post-qualification, or in the case of Consulting Services, there is no successful negotiations;

WHEREAS, in view of the failure of bid for the Project: Procurement of Broadcast Equipment to pass the post-qualification process, the Bids and Awards Committee unanimously agreed to recommend to the Head of the Procuring Entity (HOPE) a failure of the public bidding conducted last September 13, 2023 in compliance with Sec. 35.1(c) of the Revised Implementing Rules and Regulations of RA 9184;

NOW THEREFORE, WE, the Officers and Members of PBS-RTVM Bids and Awards Committee, in consideration of the foregoing, RESOLVED as it is hereby RESOLVED:

- 1) To recommend approval by the Officer-in-Charge of the Presidential Broadcast Staff (Head of the Procuring Entity) the Declaration of Failure of Bidding for the Project: Procurement of Broadcast Equipment due to the failure of thereon to comply with all the bid requirements and failed post-qualification.
