BAC RESOLUTION RECOMMENDING APPROVAL FOR DECLARATION OF FAILURE OF BIDDING

WHEREAS, the Media Production Division of the Presidential Broadcast Staff-RTVM (PBS-RTVM), has an Approved Purchase Request # 2023-12-390 dated December 1, 2023 named Procurement of Desktop/Laptop Computers and Tablets.

WHEREAS, the Procurement of Desktop/Laptop Computers and Tablets is a CY 2024 project budgeted under the 2024 National Expenditure Program (NEP) in the amount of Two Million One Hundred Eighty-Seven Thousand Five Hundred Seventy Pesos (Php 2,187,570.00).

WHEREAS, the Early Public Bidding Activity was in compliance with Section 5.0(j) of Memorandum Circular No. 2023-1 dated August 22, 2023 issued by the Inter-Agency Task Force on the Harmonization of National Government Performance Monitoring Information and Reporting Systems requiring government agencies to undertake early procurement activities covering 2024 procurement projects;

WHEREAS, the Invitation to Bid for the public bidding of Procurement of Procurement of Desktop/Laptop Computers and Tablets was continuously published at the websites of the Philippine Government Electronic Procurement System (PhilGEPS), and simultaneously at rtvm.gov.ph website and at conspicuous places from December 8 to 27, 2023.

WHEREAS, during the Pre-Bid Conference conducted on December 15, 2023 at 2:00pm, only one(1) prospective bidder, the Pastels Inc. represented by Ms. Marie Cris Buenaflor attended the conference.

WHEREAS, on December 27, 2023, bid opening day for the Project's public bidding, no bid proposal was received until the set time of 10:00am.

WHEREAS, pursuant to Sec. 35.1(a), Rule X of the Revised Implementing Rules and Regulations of RA 9184, one of the instances when the BAC shall declare a failure of bidding is when " NO BIDS ARE RECEIVED"

WHEREAS, in view that no bid was received for the Project: Procurement of Desktop/Laptop Computers and Tablets, the Bids and Awards Committee recommend to the Head of the Procuring Entity (HOPE) a failure of the public bidding conducted on December 27, 2023 in compliance with Sec. 35.1(a) of the Revised Implementing Rules and Regulations of RA 9184;

NOW THEREFORE, WE, the Officers and Members of PBS-RTVM Bids and Awards Committee, in consideration of the foregoing, RESOLVED as it is hereby RESOLVED:

1. To recommend approval by the Officer-in-Charge of the Presidential Broadcast Staff (Head of the Procuring Entity) the Declaration of Failure of Bidding for the Project: Procurement of Desktop/Laptop Computers and Tablets, in pursuance to Sec. 35.1(a) of the Revised Implementing Rules and Regulations of RA 9184;
