

MEDIA INTERVIEW IN MONTALBAN, RIZAL

REPORTER: Sir, following today's development, ano po 'yung magiging hakbang ng pamahalaan para matiyak po 'yung equitable distribution po ng tubig mula rito sa dam, lalo na po sa mga underserved areas?

PRESIDENT FERDINAND R. MARCOS JR.: Well, this is the whole point of this project, this massive project that we have done dahil nakita natin kaagad na may mga areas na hindi talaga — na nagkakaproblema sa tubig.

Kaya natin tinulungan dahil itong project na ito — at saka malaking PPP project ito kaya naman nabuo. At now, I'm very happy to be able to say that iyong mga ibang lugar na dati ay hindi regular ang kanilang supply ng tubig ay magkakaroon na ng regular na supply. And that's the important thing. That's really what this is all about.

Alam naman ninyo binubuo natin iyong Department of Water Management. Binubuo natin. Marami tayong ginagawa sa NIA para sa water management din at lahat ng ating private sector partners ay tumutulong para nga dito sa ating mga ginagawa dahil napakahalaga, napakaimportante na maganda ang suplay natin ng tubig at lalung-lalo na sa mga malalaking siyudad. Nauuna na diyan ay siyempre iyong NCR.

Ngunit, kailangan pa rin natin tingnan ang mga iba't ibang highly urbanized areas dahil mayroon din silang problema sa tubig at kailangan natin tugunan iyang problema na iyan.

So, this is a very, very good beginning. I hope it inspires other PPP projects that will bring a good supply of water, affordable supply of water, a good supply of clean water to the—what were previously underserved areas.

SEC. VELICARIA-GARAFIL: Next question, Alvin....

REPORTER: Mr. President, magandang umaga po.

PRESIDENT MARCOS JR.: Good morning.

REPORTER: Sir, can you at least give us an idea of — a preview of your upcoming third SONA, highlights, how long it would take? And sir ‘yung attire?

PRESIDENT MARCOS JR.: Iyong?

REPORTER: Attire.

PRESIDENT MARCOS JR.: Iyong alin?

REPORTER: Attire, Sir.

PRESIDENT MARCOS JR.: Well, wala. It's a SONA. Ganoon pa rin. Ibalalita ko kung ano iyong mga naging progress doon sa ating mga ginagawa. Iyong ating mga binikas noong una, noong mga unang SONA ay ire-report ko. Kasi ang SONA, report sa bayan iyan. So, ire-report ko kung talaga bang iyong mga sinimulan natin ay tuloy-tuloy at maganda pa rin ang progress at kung gaano pa katagal bago matapos iyong malalaking project na iyan.

At titingnan din natin, siyempre, we will also report on the state of the nation in the sense that what are the lives of our people, how are they doing? The economy, how is it doing? Criminality, how are we doing on that? How are we doing in the other problems, social problems that we are facing such as drugs,

such as the different threats that have been coming to us. Marami tayong mga isyu na kailangan pag-usapan.

Kaya't ire-report — report talaga sa bayan iyan. And iyon lamang sa totoo lang, ang pinaka-problema namin ay paano namin ipagkakasya lahat doon sa isang SONA na mga isang oras na salita.

Kaya't ang ginawa namin ay mayroon kaming ginawang brief, ganun kakapal which is a report to the nation, which goes into the detail. The detail that I cannot go into during the SONA dahil masyadong mahaba. Kaya't we will provide that to, of course, the media and to all our other partners both private sector, both in the public sector, pati sa mga eskwela at lahat para malaman ng tao kung ano iyong ginagawa natin at kung iyong mga pangako na ating sinabi ay kung talaga nating tinutupad.

And that's basically what the SONA is going to look like.

SEC. VELICARIA-GARAFIL: Next question po, Chona Yu, People's Journal.

MS. CHONA YU: Sir, kagabi po mayroon kayong announcement that the Philippines will host the Loss and Damage Fund.

PRESIDENT MARCOS JR.: Yes, oo, very good news iyan.

MS. YU: Sir, para po sa isang ordinaryong Pilipino, ano po ang significance nito?

PRESIDENT MARCOS JR.: Okay. Tama. Good question.

Mahalaga ito dahil iyong Loss and Damage Fund, iyan ang pondo na binibigay ng mga developed countries, iyong mga mayayaman na bansa. Iyan ang kanilang pondo na ibibigay para ayusin iyong mga naging problema sa environment dahil nga sa industrialization na ginawa nila. At sinasabi nila may damage, may loss ang mga developing countries dahil sa industrialization ng mga mayayaman na bansa.

Ngayon, nag-agree ang mga developed countries kung tawagin, nag-agree ang developed countries na magbubuo sila ng pondo para mabigyan ang

developing countries naman ng tulong dahil itong climate change na nangyari na ito ay dahil sa industrialization.

At kaya naman ang sinasabi natin — ang mga... Halimbawa, gawin na lang nating halimbawa iyong Pilipinas. Ang Pilipinas ay wala namang kinalaman sa climate change. Wala tayong ginagawa, wala tayong nilalagay sa environment na sumira at nagkaroon ng global warming, nagkaroon ng ito mga El Niño na ganito, mga bagyo na ganito. Wala naman tayong kinalaman diyan. Kaya naman dapat suportahan tayo ng mga developed countries.

Sir, the camp of Pastor Apollo Quiboloy questioned po 'yung motives ng mga private individuals na nag-offer po ng reward, 10 million reward for his arrest. Bakit daw po tumanggap ang government ng donation from the private sources?

REPORTER: Bakit hindi government?

PRESIDENT MARCOS JR.: Bakit hindi? They want to help us bring a fugitive to justice. You know, he is a fugitive. He is hiding from the law.

Now, if there are private citizens who want to assist the government in that effort to bring him to justice, I do not see what is any... He can question their motives as much as they want but magpakita siya. I question his motives. Let me question his motives. Bakit lagi kaming kinukwestiyon? Sinusundan lang namin ang batas. Sundin din niya ang batas. Iyon lang.

Iyon lang naman. Dinala nila iyong pasalubong kay First Lady.

MS DOMINGO: Sir, follow up. Ano po 'yung assistance na hinihingi ni Kris Aquino from the Marcos Administration?

PRESIDENT MARCOS JR.: I think it was just to help them for their travel arrangements. So, tumulong si First Lady at iyon lang. Sabi lang magpapasalamat sila.

And so — I think it was a very fine gesture on the part of the Aquino family. I think it was — it sort of I suppose put a little more — how do you say — personal, a human interaction between our families.
